SUMMARY OF BECKENHAM U3A'S PRIVACY STATEMENT AND GDPR POLICY

Beckenham U3A considers it is essential that all members give their consent to the collection, retention and processing of their personal data. Beckenham U3A has therefore selected the consent of members as the legal basis for doing so.

Beckenham U3A will only store, retrieve and process personal data to ensure the efficient running of the organisation and for the benefit of members.
